Rat Games is open to all breeds and mixed breeds of all sizes. Dogs must registered with Rat Games and have a number to earn points towards titles. For a complete copy of the rules or to register a dog, go to www.ratgames.com. You can grandfather in for Course Classes at higher levels from other rat hunting venues. See "Grandfathering Titles" on page 20 of the Rat Games Rule Book for details.

Facility doors open 1 hour before trial starts. Doors close 1 hour after last dog runs.

Notice to Exhibitor

- Invalid Entries Entries are not valid for the following reasons: unsigned, no payment, incorrect payment, wrong information, incomplete information, to name a few. Invalid entries will be held and not processed until all information has been completed.
- **Payment** will be processed when entry is received, i.e.: cashing of checks, run payment, etc.
 - Non-Sufficient Funds All payments returned with NSF will be subject to a \$50 fee.
 - > Checks are made payable to Canine Adventures.
 - ➤ **PayPal** available. \$1 per run for processing will be added. Once we receive your entry, we will send an invoice via email with payment instructions.

- Entries/closing dates
 - ➤ Entries will be considered "on time" if postmarked by the entry closing date posted in the premium.
 - ➤ Day of Show (DOS) Entries presented to the trial secretary on the day of a trial event during registration/check in. DOS entries will be available if time allows.
 - No entries will be accepted after the close date.
- **Confirmations** Confirmations are sent out via email. Please check for accuracy and contact the trial secretary at Lea.K9Adventures@gmail.com if changes are needed.
- **Rules** It is the handler's responsibility to read and understand the rules in the Rat Games Rule Book. Rule books can be found on the Rat Games website.

- **Bitches in season** − BIS may compete in trials for Rat Games. They must wear pants and be kept separate from other dogs. BIS will run at the end of their class. BIS must wear panties specifically designed for the purpose of prevention/containing seasonal discharges on trial grounds and when out of their crates or when being pottied. Panties must be worn to and from the designated potty area. Designated crating area will be assigned or must crate out of vehicle. Please inform the trial secretary when you arrive for additional information. Failure to do so can be grounds for dismissal.
- **☑ Dog Aggression** Any dog behaving in a threatening or aggressive manner toward another dog or person may be dismissed from the trial if justification found to do so by the judge and/or trial committee.
- **Cancellation Policy** Every attempt will be made to hold this event as scheduled. In the event of an "Act of God" such as fire, flood, etc., an event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation. We will return all or part of the entry fees at our discretion.

Withdrawals/Refunds

- ➤ **Before closing date** If a competitor withdraws before the closing date, a refund will be issued, less any processing fees, within 5 days after the trial.
- ➤ No Refunds:
 - After the closing date.
 - Or if in the event a dog and/or handler are dismissed from competition, regardless of the reason for such dismissal.
- ➤ Withdrawal due to dog injury or illness Refunds may only be given for dog illness or dog injury with a note from a Veterinarian. Notes must be presented before trial begins. A refund will be issued, less any processing fees, within 5 days after the trial.
- Crating area Please check in with the trial secretary for the designated crating area information. Crating is outdoors and out of vehicles. Dogs must be under control while on trial grounds. All dogs must be on a short leash or crated at all times unless actively working. RETRACTABLE LEASHES ARE NOT PERMITTED ON PREMISIS.
- Smoking/Vaping is not permitted within 50 feet of any straw, in the building or within 50 feet of the doorways.
- **№ Ribbons and Awards** Green flat ribbons will be awarded for all qualifying runs. Placement ribbons will be awarded 1st 4th place depending on number of dogs in class as stated on page 21 of the Rat Games Rule Book. Title rosettes will be awarded for qualifying score totals
- **Ribbon Presentation** Results will be announced shortly after each class. Ribbons will then be place on the ribbon display table to be picked up.
- **Trial Grounds** This trial will be held at Canine Adventures, located at 32250 W Eight Mile Rd, Farmington Hills, MI 48336. This is an indoor event. Heated warehouse/not airconditioned.
- **Parking** is free for this event.
- **Food** Snacks are available on site for purchase. There are also food establishments nearby.
- **Ring** Padded floor, combination of 4' black wire fence panels, 4' lattice fence panels. Indoors.
- Blind Blind will be a minimum of 10' x 20' and with a maximum number of dogs, 5.

Game Descriptions (Page 8 of Rat Games Rule Book)

<u>Heads or Tails-</u>Work your dog at a distance with limited rats on course: two in the half you are on and two in the other half (distance challenge).

<u>Distance-</u>Another distance challenge similar to Heads or Tails except the entire course is behind a distance line.

Speed-Learn how to handle stress by focusing on finding each rea within 30 seconds or less and optionally, calling clear when your dog is complete.

<u>Pairs-</u>Teamwork is beautiful thing to behold. Two people, two dogs and four minutes to find six rats. <u>Tunnels-</u>Two minutes and lots of tunnels. Complete as many as you can but no points for repeating them.

<u>Bet the Farm-</u>A point game based on speed and similar to Mad Hatter with a twist! You don't know the number of rats on a course and you may call clear when course is clear of rats for a bonus.

<u>Mad Hatter-</u>Have we gone mad?! Ten rats on course every time is a doggie smorgasbord and total fun for the dog! Have fun and find rats!

Me First-Dogs race head to head on their own mirror image courses. The first to call rat correctly wins.
